Upon completion of the course the student should have the;

Knowledge and understanding

- to explain and describe theories related to examination and treatment methods within oral health in different countries
- to describe holistic patient care within oral health.

Skills and abilities

- to independently plan and perform patient examinations as well as basic and advanced treatment methods within oral health
- to communicate with and inform patients, relatives and staff about prevention and treatment methods related to advanced caries and periodontitis.

Judgement and approach

- to perform advanced patient care based upon the professions fundamental values and patients' needs and grounded upon theoretical and evidence based knowledge.

The course is presented in the form of seminaries, group activities and clinical practice combined with reflection in the student clinic and at dental clinics.

The teaching is conducted in English.

The assessment will be based on a clinical examination and an individual written paper.
