Intended Learning Outcomes (ILO)

On completion of the course, the student should be able to:

Knowledge and understanding

- identify the role of lifelong learning in policies for social sustainability
- describe and explain theoretical concepts relating to adults' lifelong learning on individual and organizational levels

Skills and abilities

- construct theoretical frameworks for social sustainability in working life
- apply theoretical frameworks and concepts on practical cases of leading learning in working life
- analyse and reflect on the use of theoretical frameworks and concepts in relation to practical cases of leading learning in working life

Judgement and approach

- critically reflect on and discuss different aspects on leading lifelong learning for sustainable workplaces
- evaluate long-term consequences of lifelong learning effort for social sustainability

Type of instruction

The teaching consists of lectures, seminars and exercises performed individually and in groups.

A learning management system is used.

Students who have been admitted to and registered for a course have the right to receive instruction/supervision for the duration of the time period specified for the particular course instance to which they were accepted. After that, the right to receive instruction/supervision expires.

The teaching is normally conducted in Swedish, but can occasionally be in English.

Prerequisites

The applicant must hold the minimum of a bachelor's degree (ie. The equivalent of 180 ECTS credits at an accredited university) with at least 90 credits in Social Science or Education or the equivalent.

Examination and grades

The course is graded A, B, C, D, E, FX or F.

The grades A, B, C, D and E are all passing grades. For courses with more than one element of examination, students are given a final grade based on an overall assessment of all the elements included in the course. The final grade of the course is issued only when all elements of examination have been passed.

The examination is based on the intended learning outcomes.

The forms of examination are oral examination, individually and in group, and individual written assignment.

The examination must allow for students to be assessed on an individual basis. Further information concerning assessment of specific intended learning outcomes and grading criteria is provided at the beginning of the course.

To pass the course students must receive at least a passing grade on every assignment. The final course grade is determined by the grade received on Individual written assignment.

Students are guaranteed a minimum of three attempts to pass an examination, including the regular attempt.

If a student has failed the same examination three times, the student can request that the next attempt be graded by a new examiner. The decision to accept or reject such a request is made by the associate dean of education. A student may not make a second attempt at any examination already passed in order to receive a higher grade.

In case a course is terminated or significantly altered, examination according to the earlier

syllabus shall be offered on at least two occasions in the course of one year after the termination/alteration.

The examiner has the right to give an adapted examination or let the student carry out the examination in an alternative way provided that the intended learning outcomes can be secured and that there are exceptional reasons for this, including the student's right to targeted study support.
