Kunskap och förståelse

- 1. Understand the links between competition, economic efficiency and social welfare.
- 2. Understand informational asymmetries relevance in economic analysis and business decisions.
- 3. Understand the idea of network and the main economic issues associated with it.
- 4. Know the main pricing formats available to firms.

- 5. Apply models for analyzing real world phenomena within firms, markets, and competition policy
- 6. Apply economic concepts that have a broad use in economic analysis and business decisions such as; opportunity costs, network effects, strategic behavior, externality, information asymmetry, and market power.
- 7. Demonstrate ideas and solve problems using graphical, tabular, algebraic, and advanced calculus-based techniques
- 8. Identify relevant analytical tools for the analysis of concrete policy and business problems.

9. Evaluate and methodologically reflect upon the social implication of different market forms and pricing formats.

Innehåll

The course covers three main themes. The first theme is the analysis of market structures in which the sellers have market power – as opposed to being price-takers – and most notably of oligopoly and monopoly. Special attention is paid here to the firms' pricing strategies and to their implications.

A further theme is the analysis of the informational aspects of markets and organizations. The main focus is on the strategies and institutions which are motivated by informational asymmetries, such as those that typically exist both between potential exchange partners and between the parties to a contract, also to appreciate the relevance of modern information technologies.

The course also covers the economic aspects of networks in general and of networks of firms in particular. The focus here is on gains and inefficiencies driven by externalities and arrangements aiming at improving the networks' efficiency.

The approach to each topic emphasizes the aspects related to social welfare and to business strategy.

Connection to Research and Practice

The course is connected to the research front of Industrial Organisation, both theoretically and empirically. Issues connected to competition and economic efficiency are fundamental to all research areas of JIBS.

Special attention is paid to informational issues in markets and organizations, in order to allow the students to appreciate the relevance and the potential effects of the innovations that are continuously being introduced in the areas of communication and information.

Undervisningsformer

The course is delivered through lectures, workshops and exercise classes.

Förkunskapskrav

General entry requirements and 60 credits in Business Administration or Economics including Intermediate Microeconomics and Mathematical Economics (or equivalent).

Examination och betyg

Kursvärdering

It is the responsibility of the examiner to ensure that each course is evaluated. At the outset of the course, the programme evaluators in the course must be contacted. In the middle of the course, the examiner should meet the programme evaluators to identify strengths/weaknesses in the first half of the course.

At the end of the course, the examiner should remind students to fill in the survey. The examiner should also call a meeting with the programme evaluators to debrief the course, based on course evaluation data and comments. The next time the course runs, students should be informed of any measures taken to improve the course based on the previous course evaluations.

Academic integrity
