Intended Learning Outcomes (ILO)

On completion of the course the student will be able to:

Knowledge and understanding

- describe and problematise health and engagement in different activities from the perspectives of equality and equity
- describe and problematise how human activity affect sustainable development and sustainable health locally as well as globally.

- independently show clarity and logic in disposition and linguistic stringency in written reporting.

Type of instruction

The course is conducted in the form of discussions and seminars via the web-based platform.

Language of instruction is English.

Entry requirements

The applicant must hold the minimum of a bachelor's degree (i.e. the equivalent of 180 ECTS credits at an accredited university) with at least 90 credits in Occupational Therapy and completed course An Occupational Perspective of Health I, 7.5 credits or equivalent. Proof of English proficiency is required.

Examination and grades

The course is graded A, B, C, D, E, FX or F.

The course is examined by preparation, participation in four seminars and written reflection after each, one individual written report including two presentations of its contents as well as critical reviews of fellow student's work, and one individually written reflection report.

A senior lecturer serves as the course examiner.
